



### Youth Endowment Fund

The Youth Endowment Fund of Immanuel Lutheran Church (ILC) in Boise, Idaho was established in the late 1990s with an original gift of \$10,000.

The Youth Endowment Fund makes annual grants to support opportunities for our Immanuel Lutheran youth to grow in their faith and advance our purpose, "We Share God's Gift of Love with All," both within our congregation and by outreach beyond.

Annual awards are distributed and used for Youth Mission events.

Your generous gift to the Youth Endowment Fund ensures that the work of the church continues for future generations.



Gifts to the Endowment Fund may be made as a legacy gift at the end of life, and/or as a thoughtful, caring way to remember or honor a loved one, mark an occasion, or simply give to the Glory of God.

#### How can gifts be given?

Gifts may be given in the form of:

- Beneficiary designations in a will, life insurance policy, IRA, trust or annuity
- Cash or check
- Monthly online giving
- Qualified Charitable Distributions (QCD) from an IRA
- Marketable securities
- Life insurance policies
- Tangible estate property
- Real estate
- Donor-advised funds as a recipient or designee
- Charitable gift annuity

#### What about Memorials?

Memorial gifts, other than memorial gifts to the Endowment Funds, will continue to be honored and are administered apart from the Youth Endowment Fund.



## How is the Fund Managed?

The ILC Endowment Committee monitors all investments in the Youth Endowment Fund. The goal is to ensure growth of the Fund while managing risk through a diversified approach.

The annual distribution payout is calculated on the balance of the Fund. As the Fund grows, the payout of the grant awards will increase.

A standard review process is used to assure that annual grants from the Fund create, enhance or enrich the programs for Immanuel youth and are aligned with ILC's Purpose Statement and Guiding Principles.
