## Mission Endowment Fund

The Mission Endowment Fund of Immanuel Lutheran Church (ILC) in Boise, Idaho, was established in 2000 and allows for continued Christian stewardship beyond one's lifetime.

The ILC Mission Endowment Fund exists to advance our purpose, *"We share God's gift of love with all"*, both within our congregation and by outreach beyond.

The Fund is an accumulation of many gifts, large and small, given to support programs beyond our church not covered by the annual operating budget.

Annual awards will be distributed, 20% to each mission category:

- ILC (new initiatives only)
- Ada County
- USA
- Outside the USA

The remaining 20% may be divided among the recipients or left whole and awarded to one recipient.

Gifts to the Endowment Fund may be made as a legacy gift at the end of life, and/or as a thoughtful, caring way to remember or honor a loved one, mark an occasion, or simply to give to the Glory of God.

### How can gifts be given?

Gifts may be given in the form of:

- Beneficiary designations in a will, life insurance policy, IRA, trust or annuity
- Cash or check
- Marketable securities
- Tangible personal property
- Real estate

### What about Memorials?

Memorial gifts, other than memorial gifts to the endowment fund, will continue to be honored and are administered apart from the Mission Endowment Fund.

## How is the Fund Managed?

The ILC Mission Endowment Committee will monitor all investments in the Endowment Fund. The goal is to ensure growth of the Fund while managing risk through a diversified approach.

The annual distribution payout will be calculated on the balance of the Fund. As the Fund grows, the payout of the grant awards will increase.

A standard review process is used to evaluate grant applications and assure that annual grants from the Fund are aligned with ILC's Purpose Statement and Guiding Principles.
